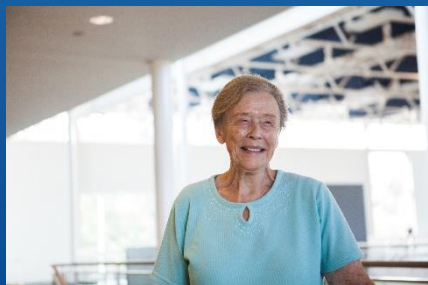

## What are my giving options?

**Bequest:** A charitable bequest can be as simple as adding a sentence or two in your will, or a codicil appended to your present will.

**RRSPs/RRIFs:** You can designate all or some funds in your Registered Retirement Savings Plan (RRSP) or Registered Retirement Income Fund (RRIF) to support the YMCA.

**Life Insurance:** Enables you to provide a significant future gift at a very modest current cost.

**Cash:** A current gift of cash is a simple way to give.

**Publicly Traded Securities or other marketable assets:** A tax effective way to gift appreciated assets.
